16 The Receiver having filed his Report on Requests for compensation and having
17 received objections thereto, the Receiver submits the following response to the objections.

18 1. The objections are summarized in the schedule hereto attached as Exhibit "A"
19 which contains a brief description of the objection and the Receiver's response. True and
20 correct copies of the written objections are attached as Exhibit "B".

21 2. The Receiver has agreed with all of the objections with the exception of the
four requests discussed below. In addition to the objections, in double checking the approved

1 requests to the initial requests filed early in this case, the Receiver has discovered three such
2 requests that were not included in the initial report filed by the Receiver. Those requests are
3 identified in the attached Exhibit "A" under the names Elkin, Gibbons, and Volk. The
4 Receiver recommends that those requests be approved in the amounts requested as reflected
5 in Exhibit "A".

6 3. Boykin, Jacqueline. The Receiver has originally denied all but \$14.06 of Ms.
7 Boykin's request. Based upon the additional documentation provided by Ms. Boykin, the
8 Receiver recommends that the request be approved in the amount of \$1,014.06. The Receiver
9 recommends denial of the remaining \$500.00 sought by Ms. Boykin for the reason that she
10 has failed to provide supporting documentation for this additional amount.

11 4. Manz, Dawn. The Receiver recommends denial of the request for \$750.00 filed
12 by Ms. Manz because it was not timely filed. The request was filed on April 9, 2007 and was
13 therefore not included in the Receiver's initial report. Ms. Manz objects to this
14 recommendation but has not provided sufficient justification for the late filed request.
15 Accordingly, the Receiver recommends that the request be denied as untimely filed.

16 5. Nieto, Pedro. The Receiver initially approved \$750.00 of the request filed by
17 Mr. Nieto and disapproved the remaining \$1,500.00 of the request due to the lack of
18 supporting proof. Mr. Nieto objected to this recommendation but has still failed to provide
19 supporting proof for the remaining amount. Accordingly, the Receiver does not recommend
20 any change in his initial recommendation.
